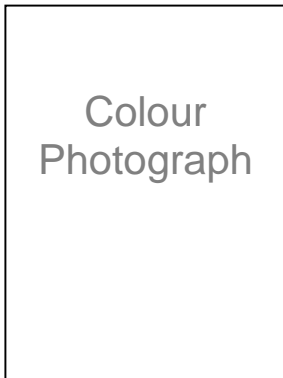

## Further Information about the Prostitution Act 1999

### The Prostitution Act 1999 (the Act)

The Act came into effect on 1 July 2000. The Act allows applications for a brothel licence or a certificate as an approved manager. The Act is available in hard copy from SDS Publications for a fee. Alternatively, the Act is available on the internet from the on-line legislation pages of the Queensland Government web site at [www.legislation.qld.gov.au](http://www.legislation.qld.gov.au).

### About the Act

The Act allows a person to apply for and be issued with a licence to operate a brothel (a brothel licence) or a certificate to manage a brothel on behalf of the licensee (certificate as an approved manager). The Act sets up a licensing regime for brothels only.

Laws relating to prostitution by sole operators can be found in the Criminal Code.

### Who are the Office of the Prostitution Licensing Authority (PLA)?

The PLA was established to issue brothel licences and certificates to approved managers.

The PLA comprises:

- the Chairperson, who is an independent, respected member of the community nominated by the Premier
- the police commissioner, or their representative
- the crime commissioner, or their representative
- a health practitioner who has at least 5 years' experience in his or her profession
- a lawyer who has knowledge or experience in administrative law, company law or criminal law
- a person who represents local government
- 2 persons who, in the Minister's opinion, are qualified to represent community interests.

### Where can I get a licence or certificate application form?

Application forms for a licence and/or certificate are available on the relevant websites or on request from the Office of the PLA. Applicants are advised that the process for receiving, vetting and considering applications may take some time.

### What is involved in setting up a brothel?

To set up a brothel and operate it lawfully will require a person to obtain a brothel licence as well as obtaining planning approval from the local government authority for the brothel. Once these two requirements are met, the brothel may be operated in accordance with State and local laws which apply to the brothel, any conditions that attach to the brothel licence and any code of practice for licensed brothels, which may be in operation.

### How much will a licence or certificate lodging cost?

Relevant fees are payable upon submitting an application. Further, annual returns and fees also apply.

A schedule of fees is available on our website – [www.pla.qld.gov.au](http://www.pla.qld.gov.au) or alternatively please contact the Office of the PLA on (07) 3858-9500.

### Who must apply for a brothel licence?

Any person who operates a brothel and who will be receiving direct income from a brothel must be licensed under the Act. A sole operator who carries on the business of providing prostitution does not require a brothel licence.

If you propose to operate a brothel in partnership with, or otherwise in association with, any other person, each person must be individually licensed and pay the prescribed fees. For example, a person is considered to operate a brothel in association with another person if the person directly receives income from the brothel.

In this instance applications from partners must be submitted and received by the PLA at the same time. This means that each applicant must complete an application form and pay an application fee. However, only one brothel licence fee is payable.

A schedule of fees is available on our website – [www.pla.qld.gov.au](http://www.pla.qld.gov.au) or alternatively please contact the Office of the PLA on (07) 3858-9500.

### Who must apply for a manager's certificate?

A licensed brothel business must be personally supervised by the licensee or an approved manager at all times that it is open for business. If you wish to work as a brothel manager, you must apply to the Office of the PLA.

## Where can I set up a brothel?

Like any other business, the decision as to where a brothel may be located is largely a matter for local authorities. A development approval will not be granted by the local authority if the proposed brothel -

- is in or within 200 metres of the closest point on any boundary of a primarily residential area or an area approved for residential development or intended to be residential in character, measured according to the shortest route a person may reasonably or lawfully take, by vehicle or on foot, between the application land and the other land; or
- is within 200 metres of the closest point on any boundary of land on which there is a residential building, place of worship, hospital, school, kindergarten or any other facility or place regularly frequented by children for recreational or cultural activities, measured according to the shortest route a person may reasonably or lawfully take, by vehicle or on foot, between the application land and the other land; or
- the application land is within 100 metres of the closest point on any boundary of land on which there is a residential building, place of worship, hospital, school, kindergarten, or any other facility or place regularly frequented by children for recreational or cultural activities, measured in a straight line; or
- has more than five rooms, which are to be used for providing prostitution.

Also, it is possible for the local authority of a town with less than 25,000 residents to automatically refuse development applications for brothels, if the local authority has sought and received approval from the relevant Minister.

## Number of Service Rooms and Sex Workers at brothels

Brothels are only permitted to operate with a maximum of five rooms and no more. At any one time the number of sex workers on the premises must not total more than:

Number of rooms permitted at licensed brothel under development permit	Number of prostitutes at licensed brothel at any 1 time
1	2
2	3
3	4
4	6
5	8

For example, if you have development approval to operate a 5 room brothel, and you hold a brothel licence for 5 rooms, you must not have more than 8 sex workers at the brothel at the one time. The total number of staff at a brothel must not exceed 13 staff at any one time.

## How do I apply for development approval?

If you wish to apply for approval to use a building for a licensed brothel (development permit) you should contact your local authority. The local authority will be able to provide you with information about assessing the development application.

## What is the IDAS Code for development applications?

The IDAS Code is the Integrated Development Assessment System which applies for the assessment of a development application under the Sustainable Planning Act 2009 for the making of a material change of the use of premises for a licensed brothel.

## What is the purpose of the IDAS code?

The purpose of this code amongst other things, seeks to ensure –

- a licensed brothel is compatible with the form, function and amenity of the area in which it is located; and
- the safety and security of staff of a licensed brothel.

## How do I comply with the code?

The code is complied with if each performance criterion in the table on page 13 is complied with for the brothel. A performance criterion is complied with if –

- the acceptable solution to the performance criterion set out in the table opposite the criterion is complied with, or
- the criterion is complied with in another way.

## What general information can I get about applications received by the Office of the PLA?

The Office of the PLA cannot disclose any information obtained by them in the administration of the Act unless it is for a lawful purpose. A lawful purpose includes instances such as in a proceeding before a court in which the information is relevant to the issue before the court, in a proceeding under the Act or, with the approval of the PLA, to a person administering a corresponding law.

The Freedom of Information Act 1992 does not apply to a document given to or produced by the Office of the PLA for the Act.

### Do I need to have premises before I apply for a brothel licence?

The PLA will not be able to grant you a licence if you have not provided any details regarding the premises. However, the PLA may consider your application regardless of whether or not you have obtained development approval for the proposed brothel premises.

If you have a premises in mind but you have not received development approval, you may still proceed with your brothel licence application. You should, however, provide full details of the proposed premises and advise the Office of the PLA of any changes to your intended premises within 10 days of becoming aware of the changes.

### What comes first – the brothel licence or development approval?

You may either obtain development approval from the relevant local authority first or you may decide that both application processes should occur at the same time.

### What happens if I receive development approval for the land, approval from the PLA but the premises have not yet been built?

You may ask the Office of the PLA to postpone the issue of the licence to you until the 'happening of an event'. For example, if the premises will not be constructed for another 5 months, you may ask PLA to postpone the issue of the licence for 5 months. If the PLA is satisfied that it is reasonable in the circumstances to postpone the issue of a licence the PLA can postpone giving you the licence for a period decided by the PLA. Should you require a further extension, the PLA may also extend the period of time.

### Who is ineligible to apply for a licence or certificate?

The Act sets out a number of categories of persons who are not eligible to obtain a licence or certificate. A brothel licence or manager's certificate will not be issued to -

- a corporation;
- a minor;
- an insolvent under administration;
- anyone who holds a licence or permit under the Liquor Act 1992;
- anyone who has been convicted of a disqualifying offence (described below);
- anyone who has had a licence, certificate or other authority under the Act or under a corresponding law in another State to provide prostitution at a brothel or to manage a brothel cancelled in the last three years;

- anyone who has been declared by the PLA to be ineligible to apply for a licence or certificate.

### What is a 'disqualifying offence'?

A 'disqualifying offence' is defined in the Act as an offence or an attempt to commit or to conspire to commit or to counsel or procure a person to commit any of the following:

- Section 250 of the Criminal Proceeds Confiscation Act 2002 (money laundering);
- Section 5 of the Drugs Misuse Act 1986 (Trafficking in dangerous drugs);
- Official corruption;
- Unlawful homicide or attempt to murder;
- Rape or attempt to commit rape;
- Kidnapping;
- Demanding property, benefit or performance of services with threats;
- Offences against morality that relate to a child or an intellectually impaired person;
- Prostitution offences that relate to a child or an intellectually impaired person;
- A provision of Schedule 2 of the Migration Act 1958 (C'wlth),
- or an offence that, if committed in Queensland, would be a disqualifying offence as described above.

### If I am eligible to apply for a licence or a certificate will I get one?

Not necessarily. All applications will be subject to rigorous vetting by the Office of the PLA and the Queensland Police Service. This will include checking the criminal history of the applicant and their family and associates. The Office of the PLA may also seek advice and information on the application from any other entity it considers appropriate, and require the applicant to give further information it considers relevant to the application.

A brothel licence applicant's financial background and the financial viability of the brothel will also be checked.

The Office of the PLA will also consider the business structure for the operation of the brothel, which will include the identification of all associates (individuals or bodies corporate).

Applicants for a brothel licence will also be required to submit a business and operational plan together with the application, which must include arrangements to ensure the safety of persons directly involved in providing prostitution and any other arrangements necessary to comply with the Act.

The applicant must consent to having their palm prints, fingerprints, handwriting, voiceprints or footprints taken by the Office of the PLA or Queensland Police Service as well as photographs of the person's identifying features.

Should the applicant refuse to allow their identifying particulars to be taken, the PLA must refuse to consider the application. Should the applicant fail to give any further information required by the Office of the PLA, the applicant is taken to have withdrawn the application.

Before approving a licence or certificate, the PLA must be satisfied that the applicant is a suitable person to hold a licence or certificate. In making that decision, the PLA must consider all relevant matters. In the case of an applicant for a licence, the matters to be considered include -

- the applicant's reputation, having regard to character, honesty and integrity;
- whether the applicant has been convicted of an indictable offence, an offence against the Act or an offence against a similar law in another jurisdiction;
- whether the applicant has been convicted of an offence, the circumstances of which constitute the running of a brothel;
- whether the applicant has been charged with any offence of a sexual nature that involves violence, intimidation, threats or children;
- whether the applicant has the financial resources to ensure the financial viability of the brothel;
- whether the applicant has arrangements in place to ensure the safety of workers on the premises;
- that the business structure for the operation of the brothel is sufficiently transparent to enable all associates of the applicant to be readily identified;
- whether the applicant is an associate of a person who has been convicted of a disqualifying offence or an indictable offence;
- whether the applicant is an associate of a person who holds a licence or permit under the Liquor Act.

In the case of an applicant for a manager's certificate, the matters to be considered by the PLA include -

- the applicant's reputation, having regard to character, honesty and integrity;
- whether the applicant has been convicted of an indictable offence, an offence against the Act or an offence against a similar law in another jurisdiction;

- whether the applicant has been convicted of an offence, the circumstances of which constitute the running of a brothel;
- whether the applicant is an associate of a person who has been convicted of a disqualifying offence or an indictable offence;
- whether the applicant has been charged with any offence of a sexual nature that involves violence, intimidation, threats or children.

If an applicant for a licence or certificate becomes aware of any change in the information contained in the application, they must, within 10 days after becoming aware of the change, give particulars of the change to the Office of the PLA by signed notice.

Finally, before the PLA can grant a licence it must consider whether the combined total of licensed brothels and adult entertainment permits in the proposed area for the brothel would substantially affect the character of the locality. An example of character of locality being substantially affected is the area becoming a 'red light district'.

#### Who can assist me in developing a business or operational plan?

This is a matter for you to decide. You should seek professional advice.

#### What happens when the PLA considers my application?

The PLA may either-

- grant the licence or certificate with or without conditions or restrictions; or
- refuse to grant the licence or certificate.

The applicant may ask the PLA to postpone the issue of a licence or certificate until the 'happening of an event'. For example, development approval for the brothel is issued; construction of the premises to operate as a brothel is completed or until the brothel commences operation.

A licence authorises a person to operate a brothel at one premises only. Prostitution may only take place at the premises stated in the licence. In other words, no outcalls from the brothel.

#### What happens if I withdraw my application or the PLA rejects my application?

If you withdraw your application at any time before the licence or certificate is issued, or the PLA rejects your application, the Office of the PLA must refund the licence or certificate fee.

#### How long is the licence or certificate valid?

Once a person is granted a licence or certificate their licence or certificate will be valid for 3 years from the date of issue unless it is suspended, cancelled or surrendered.



## Annual returns and fees

The holder of an approved manager's certificate or brothel licence must give the PLA an annual return, in the approved form, about the information given for the application for the certificate or licence and pay the relevant annual fees on or before the anniversary day (the date in each year that is the anniversary of the grant of the certificate or licence).

## Who can use the licence?

A licence -

- is personal to the licensee; and
- is not transferable to any other person; and
- does not vest by operation of law in any other person; and
- is subject to any conditions or restrictions set out in the licence or prescribed under a regulation.

In other words, you cannot transfer your licence to anyone else or allow another person to use your licence. Only the person whose name and photograph appears on the licence (the licensee) can use it.

## Personal supervision of a licensed brothel

Whenever a licensed brothel is open for business, either the licensee or an approved manager must personally supervise the brothel at all times. Should a licensee or approved manager not be in attendance at the brothel, both the licensee and the approved manager (whose duty it was to personally supervise the business at the time) commit an offence.

## When can a manager act as a licensee?

If a licensee dies or becomes incapable of discharging the duties of a licensee because of physical or mental incapacity, the approved manager may apply to the PLA for authorisation to act as the licensee of the brothel specified in the licence.

Should the PLA authorise this, the licence will be endorsed to show that the approved manager is acting as licensee for the period endorsed on the licence. The approved manager is then subject to the obligations of a licensee under the Act.

### I have a conviction for prostitution. Can I still get a licence or certificate?

A conviction for prostitution alone does not preclude a person from obtaining a licence or certificate.

However, the PLA must refuse to grant a licence if it is satisfied that the applicant -

- is not a suitable person to operate a licensed brothel;
- has an interest in another licensed brothel; or
- holds a licence or permit under the Liquor Act 1992.

In the case of an application for a manager's certificate, the PLA must refuse to grant a certificate if it is satisfied that the applicant -

- is not a suitable person to be an approved manager of a licensed brothel;
- has an interest in another licensed brothel otherwise than as an approved manager of the other brothel.

### Can I advertise prostitution services?

Yes, but the Act places restrictions on the nature of advertising allowed for prostitution services. All advertising must be in an approved form. The PLA has published *Guidelines about the Approved Form for Advertisements for Prostitution*, which may be downloaded from the PLA website.

In addition to being in the approved form, any advertising for prostitution must not -

- state, directly or indirectly, that the person's business provides or is connected with massage services;
- describe the services offered;
- be published through radio or television or by film or video recording;
- intend or be likely to induce a person to seek employment as a prostitute.

### Prostitution Regulation 2014

The Prostitution Regulation 2014 contains some additional requirements for brothel licensees, and should be read in conjunction with the Act. The Prostitution Regulation 2014 is also available on the internet from the on-line legislation pages of the Queensland Government web site at [www.legislation.qld.gov.au](http://www.legislation.qld.gov.au).

## What are the licensee's duties about alarms, lights and signs?

A licensee of a brothel must ensure –

- each room in the brothel has a concealed alarm button, or equivalent communication device, that is in working order; and
- each room in the brothel has enough lighting to enable the sex workers to check clients for clearly visible signs of sexually transmissible disease; and
- a sign is prominently displayed in the brothel's reception area stating 'only safe sexual activities are practised on these premises'.

## Licence and certificate register

The Act requires that a register be kept which records the following particulars:

- the name of each holder of a licence or certificate;
- the granting, renewal, surrender, suspension or cancellation of a licence or certificate;
- the address of the premises at which the holder of a licence may operate the brothel under the licence;
- the addresses of the licensed brothels for which the holder of a certificate is authorised to be an approved manager;
- all entries into licensed brothels by police officers.

The register may be inspected at the Office of the PLA during office hours, and a copy of an entry in the register can be obtained on payment of the relevant fee.

# Definitions used in association with the *Prostitution Act 1999*

## Useful Definitions

The following definitions are provided for your reference only. Full definitions are available under the Act.

**"associate"** means any person who-

- (a) is a member of the individual's family; or
- (b) has entered into a business arrangement or relationship with the individual for the provision of prostitution; or
- (c) is the owner or lessor, either alone or jointly, of premises used or proposed to be used for the provision of prostitution under licence; and
- (d) includes an **"associate"** of a body corporate if the person is an executive officer of the body corporate.

**"brothel"** means premises made available for prostitution by 2 or more prostitutes at the premises.

**"corporation"** includes a body corporate or politic.

**"corresponding law"** means a law of another State corresponding to this Act.

**"development permit"** means a development permit granted under the *Sustainable Planning Act 2009*.

**"disqualifying offence"**

- money laundering under section 250 of the *Criminal Proceeds Confiscation Act 2002*
- trafficking in dangerous drugs under section 5 of the *Drugs Misuse Act 1986*
- the Criminal Code offences of Official corruption; official corruption not judicial but relating to offences; unlawful homicide; attempt to murder; rape; attempt to commit rape; kidnapping; kidnapping for ransom; demanding property; benefit or performance of services with threats; an offence against morality in chapter 22 if the offence relates to a child or

intellectually impaired person; or a prostitution offence in chapter 22A if the offence relates to a child or intellectually impaired person.

- Migration offences under Schedule 2 of the *Migration Act 1958 (C'wlth)*.

**"exempt prostitution service provider"** section 23 of the *Prostitution Control Act 1994 (VIC)* provides that certain persons who carry on a prostitution service providing business are exempt from the requirement to be licensed.

**"family"** of an individual, consists of the following members-

- (a) the individual's spouse;
- (b) each of the individual's children who is 18 years or more, including a stepchild, an adopted child and a person for whom the individual was foster-parent or guardian when the person was a child;
- (c) each of the individual's parents, including a step-parent, and a person who was a foster-parent or guardian for the individual when the individual was a child;
- (d) each of the individual's siblings who is 18 years or more, including a step-sibling and a person who was a foster-sibling when the individual was a child.

**"indictable offence"** Crimes and misdemeanours are indictable offences. An indictable offence is a more serious offence that is usually decided in the District of Supreme Court. Examples include murder, rape, robbery, assault and break and enter.

**"interest in a brothel"** a person has an "interest in a brothel" if the person-

- (a) is the licensee of the brothel; or

- (b) is a member of the family of the licensee of the brothel; or
- (c) is an approved manager of the brothel; or
- (d) is a member of the family of an approved manager of the brothel; or
- (e) is the owner, either alone or jointly, of premises used by the licensee of the brothel for the provision of prostitution; or
- (f) is a member of the family of an owner mentioned in paragraph (e); or
- (g) is the lessor of the premises used by the licensee of the brothel for the provision of prostitution; or
- (h) is a member of the family of a lessor mentioned in paragraph (g); or
- (i) has entered into a business arrangement or relationship with another person for the provision of prostitution at the brothel; or
- (j) directly receives income from the provision of prostitution at the brothel; or
- (k) is able to exercise a significant influence over the operations of, or in relation to the provision of prostitution at, the brothel; or
- (l) is an executive officer of a body corporate that is a person mentioned in paragraphs (e), (g), (i), (j) or (k)
- (m) for (1)(i), (j) and (k), a prostitute does not have an interest in a brothel merely because the prostitute is entitled by way of remuneration to a proportion of the payments made for the provision of prostitution by the prostitute at the brothel.
- (n) If a financial institution is a mortgagee of premises used by the licensee of a brothel for the provision of prostitution, the institution does not have an **"interest in a brothel"** only because the institution is a mortgagee of the premises.

**"minor"** a person under the age of 18

**"operate"** a brothel means to carry on the business of providing prostitution at the brothel.

**"partnership"** is the -

- state or condition of being a partner; participation; association; joint interest.
- relation subsisting between partners.

**"prostitution"**

(1) a person engages in "prostitution" if the person engages, or offers to engage, in the provision to another person, under an arrangement of a commercial character, of any of the following activities -

- (a) sexual intercourse;
- (b) masturbation;
- (c) oral sex;
- (d) any activity, other than sexual intercourse, masturbation or oral sex, that involves the use of 1 person by another for his or her sexual satisfaction involving physical contact.

(2) However, a person does not engage in prostitution if –

- (a) the activity is an activity mentioned in subsection (1)(d); and
- (b) the person is providing adult entertainment under an adult entertainment permit and is an adult and is not an intellectually impaired person; and
- (c) the activity is authorised under the permit.

(3) Subsection (1) applies equally to males and females.

**"trustee"** a person -

- (a) or one of a body of person's, appointed to administer the affairs of a company, institution etc.
- (b) who holds the title to property for the benefit of another.

## COLLECTION AND PROTECTION OF CONFIDENTIAL INFORMATION

Information is collected from licence and certificate applicants to determine their ongoing eligibility and suitability for a brothel licence or manager's certificate and to support decisions by the Prostitution Licensing Authority to grant or refuse licences and certificates.

Applicants supply detailed information through application forms about their personal, business and financial arrangements, their criminal histories and prior involvement in prostitution, their employment history, and their associates as defined by *the Prostitution Act 1999*. In addition to information sought through application forms, some information is sought from other agencies and financial institutions. Once an individual has made an application to the Office of the Prostitution Licensing Authority, records of contact between Prostitution Licensing Authority staff and the applicant may also be kept.

Access to records containing applicant personal information is granted to the staff of the Office of the Prostitution Licensing Authority. The Office of the Information Commissioner, the Crime and Misconduct Commission and the Ombudsman may have access to Prostitution Licensing Authority records containing personal information in the course of their official duties.

All information collected by the Office of the Prostitution Licensing Authority in application forms is made available to the Queensland Police Service pursuant to sections 14 and 39 of the *Prostitution Act 1999*. The names and dates of birth of applicants and their associates are disclosed to the Liquor Licensing Division and to the Business Licensing Authority (Victoria) for relevant checks. The names of all companies with which applicants are associated are disclosed to the Office of Fair Trading and the Australian Securities and Investments Commission in the course of inquiries.

Personal information about applicants is kept in both paper and electronic formats. Applicant's personal information is retained in locked filing cabinets at the Office of the Prostitution Licensing Authority and will be retained in accordance with the requirements of the *Libraries and Archives Act 1988*. Electronic information is retained in a password-protected environment.

If an individual believes that their personal information has not been dealt with appropriately, they may make a complaint to the Prostitution Licensing Authority. A complaint must be made in writing within six months from the date when the breach was suspected to have occurred.
